PRIVACY POLICY

This privacy policy governs your use of the software application Winn Analytical ("Application") for mobile devices that was created by Canopy Upstream, LLC. The Application is used by field technicians in the oil and natural gas industry to document the collection of natural gas samples and review historical chromatographic analysis.

What information does the Application obtain and how is it used?

User Provided Information

The Application obtains the information you provide when you download and use the Application. Registration is not required to purchase or download the application. This application does require prior registration with a third-party analytical laboratory. Such registration is the responsibility of these third-party laboratories and you.

When you open this application, you will be asked to provide the username and password provided to you by the third-party laboratory. You will have the option of saving these credentials within the application for future logins. To protect your privacy, your password is not visible as plain-text within the application.

We will never share, sell, or otherwise distribute your login information.

Automatically Collected Information

In addition, the Application may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile devices unique device ID, the IP address of your mobile device, your mobile operating system, and information about the way you use the Application.

Does the Application collect precise real time location information of the device?

When you use this application, we may use GPS technology (or other similar technology) to determine your precise current location in order to determine the where you are when you submit data to the third-party laboratory. We will not share your current location with other users or partners.

If you do not want us to use your location for the purpose set forth above, you should turn off the location services for the mobile application located in your account settings or in your mobile phone settings and/or within the mobile application. Please note that your third-party laboratory may require this location information, and refusal to provide location data may disqualify you from the use of their services.

Do third parties see and/or have access to information obtained by the Application?

Yes. We will share your information with third parties only in the ways that are described in this privacy statement.

We may disclose User Provided and Automatically Collected Information:

- ï as required to provide analytical sample data;
- ï as required by law, such as to comply with a subpoena, or similar legal process;
- i when we believe in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request;
- ï with our trusted services providers who work on our behalf, do not have an independent use of the information we disclose to them, and have agreed to adhere to the rules set forth in this privacy statement.
- i if Canopy Upstream, LLC is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our Web site of any change in ownership or uses of this information, as well as any choices you may have regarding this information.

What are my opt-out rights?

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network.

Data Retention Policy, Managing Your Information

Canopy Upstream, LLC does not store, archive, or otherwise maintain User Provided data. The third-party laboratory will retain User Provided data for as they deem necessary. We will retain Automatically Collected information for up to 24 months and thereafter may store it in aggregate. User Provided data becomes the exclusive property of the third-party laboratory once it has been transmitted, and therefore cannot be deleted at the users request. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Children

We do not use the Application to knowingly solicit data from or market to children under the age of 13. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact use at development@canopyupstream.com. We will work with third-party laboratories to delete such information within a reasonable time.

Security

We are concerned about safeguarding the confidentiality of your information. We provide physical, electronic, and procedural safeguards to protect information we process and maintain. For example, we limit access to this information to authorized employees and contractors who need to know that information in order to operate, develop or improve our Application. Please be aware that, although we endeavor provide reasonable security for information we process and maintain, no security system can prevent all potential security breaches.

If you reside outside the United States your information will be transferred, processed and stored there under United States privacy standards.
